The WSAS is proud to announce the **Memorial “Mladen Parun” 2009 - a three round slalom** on September 25<sup>th</sup>, 26<sup>th</sup> & 27<sup>th</sup> in commission and with permit of the Water Ski Association of Serbia on our picture site on Ada Ciganlija, Belgrade - 5 minutes from downtown.

Traditionally, the Lake in Belgrade will provide super conditions for dedicated slalom-skiers of all ages.

Saturday, September 26 <sup>th</sup> :	10.00 – 18.00	Round 1 & Round 2
Sunday, September 27 <sup>th</sup> :	11.00	Continuation & Final round

Prize giving ceremony will be held as soon as possible after the end of the competition. The definite schedule will be established by the chief judge in accordance with the organizing committee.

**Training:**

Training on the site will be possible from September 23<sup>th</sup> and will be charged € 2.00 per minute per skier.

Official training on Friday will be free of charge (two passes for each competitor).
